Certification for Commercial Driver License (Form 431211) must be completed by every person applying for a new, duplicate or renewal of a CDL or when upgrading a CDL. In addition to various certifications, you must indicate if you are subject to and meet driver qualifications for **inter**state or **intra**state operation. In some cases a driver may not be subject to either of the qualifications if exemptions apply.

## Definitions:

**Inter**state commerce - moving goods or passengers across a state line, including international boundaries, or wholly within one state as part of a through movement that originates or terminates in another state or country.

**Intra**state commerce - moving goods or passengers solely within the State of Iowa providing those goods and passengers originate in Iowa and their destination is within Iowa.
